NARRATIVE:

\*ATTENTION- DETECTIVE CASSIDY IN CHILD ABUSE, AND DETECTIVE LIEUTENANT WHITESELL\*ON 06/22/08, AT APPROXIMATELY 17:26HRS, I, OFFICER PERKINS, OFFICER COOPER (ID C2020), AND OFFICER HUXLEY (ID H2692), ALL OF THE INDIANAPOLIS METROPOLITAN POLICE DEPARTMENT WERE DISPATCHED TO [REDACTED] MEDFORD AVENUE ON A REPORT OF A DISTURBANCE WITH A KNIFE. OFFICER COOPER AND OFFICER HUXLEY ARRIVED ON SCENE FIRST AND APPROACHED THE REAR OF THE RESIDENCE WITH THE COMPLAINANT, LATER IDENTIFIED AS DORIS MCNEIL WITH A DATE OF BIRTH OF [REDACTED] WAS FLAGGING DOWN OFFICERS. MCNEIL TOLD OFFICER COOPER AND OFFICER HUXLEY, "I'VE GOT A PEDIFILE IN MY HOUSE AND I JUST WANT HIM OUT." OFFICER COOPER ASKED THE NAME OF THE SUSPECTED PEDIFILE AND MCNEIL STATED, "[REDACTED]", YOU NEED TO GO IN AND GET HIM OUT." OFFICER COOPER THEN STATED THAT OFFICERS NEEDED TO GET MORE INFORMATION ON THE SUSPECT FOR OUR SAFETY, SINCE MCNEIL HAD STATED TO DISPATCH THAT [REDACTED], DID IN FACT HAVE KNIFE. AT THIS TIME, I WAS WALKING UP TO THE SCENE FROM MEDFORD AVENUE AVENUE WHERE I HAD PARKED. WHEN I ARRIVED, MCNEIL LOOKED AT ME AND STATED, "THAT MOTHERFUCKER IS A PEDIFILE AND I CALLED HIM OUT ON IT AND HE GOT A KNIFE, AND THAT MOTHERFUCKER TRIED TO CUT ME. OFFICER COOPER AND OFFICER HUXLEY WERE TRYING TO GET MORE INFORMATION ON HIS LOCATION, WHEN MCNEIL PUT HER HAND UP AND LEANED TOWARDS ME, LOOKED AT MY NAME TAG AND STATED, "YOU ARE AN ARROGANT MOTHERFUCKER AND SO IS HE," POINTING TO OFFICER HUXLEY. AT THIS TIME, I HAD NOT SAID ONE WORD TO MCNEIL. MCNEIL THEN LOOKED AT OFFICER COOPER'S NAME TAG AND SAID, "I'LL TALK TO HIM, CAUSE HE'S THE ONLY ONE NOT BEING ARROGANT." I THEN STATED THAT WE JUST NEED MORE INFORMATION AND WE WERE THERE TO HELP HER. MCNEIL STATED, "YOU'RE ARROGANT AND I DON'T LIKE YOU, YOU AINT HERE TO HELP ME. YOU ARE A RACIST MOTHERFUCKER LIKE ALL OF THE REST." SHE THEN ASKED, "WHAT DISTRICT YOU FROM?" OFFICER COOPER STATED, " WE ARE ALL FROM THE NORTHWEST DISTRICT. I THEN STATED, "WE HAVE WORKED OUT HERE FOR YEARS, WHY DO YOU ASK?" MCNEIL STATED, "YOU NEED TO CALL CAPTAIN ZELINSKI." (OFFICERS ON SCENE BELIEVED THAT SHE WAS REFERRING TO MAJORS SISELSKI).AFTER HAVING BEEN SIDE TRACKED FROM THE ORIGINAL COMPLAINT, OFFICER COOPER AND OFFICER HUXLEY REPEATEDLY ASKED, "WHERE IS THE GUY WITH THE KNIFE. MCNEIL STATED THAT HE WAS IN THE FRONT ROOM OF THE HOUSE, BUT WAS POINTING TO THE BACK YARD OF THE DWELLING. MCNEIL THEN STARTED EXPLAINING THAT THIS WAS DOUBLE AND NOT ONE LARGE HOUSE AND CONTINUED TO RAMBLE ON ABOUT THIS. OFFICER COOPER AGAIN ASKED HER, "IS HE IN THIS ROOM?" AND POINTED TO THE FRONT ROOM FROM THE DRIVEWAY IN WHICH WE WERE STANDING. MCNEIL BECAME EXTREMELEY ANGRY AND CONTINUED TO YELL STATING, "NO, COME HERE!" AS SHE WALKED TO THE BACK YARD OF THE DWELLING. OFFICER HUXLEY STATED, "MAAM, WE ARE NOT GOING BACK HERE UNTIL YOU TELL US WHERE THE GUY WITH THE KNIFE IS."MCNEIL SAID, "YOU MOTHERFUCKERS ARE GOING TO GET THIS GUY

OUT OF MY HOUSE," AND CONTINUED TO WALK TO THE BACKYARD. I THEN CALLED FOR A SUPERVISOR DUE TO ME MCNEIL'S UNCOOPERATIVE AND BELLIGERENT BEHAVIOR AND THE FACT THAT SHE CONTINUED TO ASK WHO OUR SUPERVISORS WERE. MCNEIL THEN WALKED BACK AROUND TO THE FRONT OF THE HOUSE AND WENT IN THE FRONT DOOR WHILE YELLING, "YOU GUYS ARE A BUNCH OF RACIST MOTHERFUCKERS, YOU AINT HERE TO HELP!" MYSELF, OFFICER HUXLEY, AND OFFICER COOPER THEN WENT TO THE REAR OF THE DWELLING TO THE OTHER HALF OF THE DOUBLE TO LOOK FOR THE MAN WITH THE KNIFE. WHEN WE FOUND THAT THERE WAS NO ONE IN THE DOUBLE, WE RETURNED TO THE DRIVEWAY TO WAIT ON A SUPERVISOR TO ARRIVE. MCNEIL STARTED YELLING SOMETHING FROM THE REAR OF THE RESIDENCE AND OFFICER COOPER AND OFFICER HUXLEY RETURNED TO THE BACK YARD, ASSUMING THAT SHE WAS ARGUING WITH THE MAN INVOLVED THAT HAD THE KNIFE. WHEN THEY ARRIVED IN THE BACKYARD, MCNEIL HAD BUSINESS CARDS AND TRIED TO GIVE ONE TO OFFICER COOPER AND OFFICER HUXLEY, OFFICER COOPER STATED TO MCNEIL THAT HE DID NOT NEED HER BUSINESS CARD, BUT RATHER TO FIND OUT MORE INFORMATION ABOUT THE GUY WITH THE KNIFE. MCNEIL THEN STARTED WALKING TOWARDS ME WITH A BUSINESS CARD IN HAND. WHEN I DID NOT ACCEPT HER CARD, SHE BECAME EVEN MORE ANGRY. I WAS STANDING IN THE BACK YARD WHEN MCNEIL PLACED BOTH OF HER ARMS OUT AND KNOWINGLY AND INTENTIONALLY PUSHED ME IN THE UPPER CHEST AREA OF MY BODY IN A RUDE, INSOLENT AND ANGRY MANNER WHILE I WAS ENGAGED IN EXECUTION OF MY OFFICIAL DUTY. DURING THE PUSH, MCNEIL DROPPED ITEMS IN HER HAND, INCLUDING HER CELL PHONE AND WHAT WAS LATER IDENTIFIED AS HER CITY-COUNTY COUNCIL BUSINESS CARDS. MCNEIL'S ARMS THEN CROSSED IN FRONT OF AND SHE CONTINUED TO PUSH THROUGH ME WITH HER FOREARMS/BODY. WHEN THIS HAPPENED, I FELL BACKWARDS, STRIKING MY LEFT HAND ON THE HOUSE, CAUSING REDNESS, BRUISING, SWELLING, AND PAIN. OFFICER COOPER AND OFFICER HUXLEY WITNESSED THIS INCIDENT AND IMMEDIATELY CAME TO MY ASSISTANCE. I ORDERED MCNEIL TO PUT HER HANDS BEHIND HER BACK AND SHE YELLED, "NO, YOU CAN'T ARREST ME, I'M ON THE CITY-COUNTY COUNCIL," AND CONTINUED TO YELL OUT NAMES OF VARIOUS CITY OFFICIALS THAT WE NEEDED TO CONTACT. OFFICER HUXLEY IMMEDIATELY GRABBED HER LEFT ARM TO PLACE HANDCUFFS ON HER. MCNEIL FORCIBLY RESISTED ALL OFFICERS PRESENT BY REFUSING TO COMPLY WITH OFFICERS ORDERS TO KEEP HER HANDS BEHIND HER BACK. MCNEIL CONTINUED TO PULL HER RIGHT ARM AWAY FROM OFFICERS. MCNEIL CONTINUED TO PULL HER ARMS TO HER CHEST AND TWISTED AT THE WAIST, CAUSING HER SHOULDERS TO SWAY BACK AND FORTH IN AN ATTEMPT TO PREVENT HER FROM BEING HANDCUFFED. MCNEIL CONTINUED TO YELL, "YOU CAN'T ARREST ME." MCNEIL CONTINUED RESISTING BY PUSHING HER SHOULDERS INTO ME AND USED HER BODY WEIGHT TO KNOCK ME OFF BALANCE AND TO ATTEMPT TO BREAK FREE FROM OFFICER HUXLEY AND OFFICER COOPER'S GRASP. WHILE MCNEIL WAS RESISTING, A BLACK MALE IDENTIFIED AS [REDACTED], WITH A DATE OF BIRTH OF [REDACTED] CAME FROM THE STREET AND AROUND A CAR AND APPROACHED ME FROM BEHIND. [REDACTED] HAD TO BE TOLD THREE SEPARATE TIMES TO STEP BACK AWAY FROM OFFICERS. IT WAS NOT UNTIL I DIRECTED MY TASER AT HIM THAT HE COMPLIED WITH THE ORDER TO STEP

AWAY. OFFICERS WERE ABLE TO SECURE MCNEIL IN HANDCUFFS AFTER STRUGGLING FOR APPROXIMATELY ONE MINUTE. MCNEIL CONTINUED TO BE DISORDERLY AND YELLED TO THE NAMES OF OFFICIALS THAT SHE KNEW AND DEMANDED THAT WE CONTACT THEM. WE ASSURED HER THAT OUR SUPERVISORS WERE ON THEIR WAY AND THAT THEY WOULD SPEAK TO HER ONCE THEY ARRIVED. MCNEIL CONTINUED TO YELL RACIAL SLURRS AT OFFICERS AND STATED, "ALL THE WHITE OFFICERS ON THIS FUCKIN DEPARTMENT ARE RACISTS," OFFICER COOPER WAS ESCORTING MCNEIL TO THE FRONT OF THE HOUSE BY HOLDING ON TO THE UPPER PART OF HER LEFT ARM WHEN SHE ATTEMPTED TO PULL AWAY AND STATED, "I'M NOT GOING TO BE ARRESTED." AT THIS TIME, OFFICER COOPER USED A WRIST LOCK TECHNIQUE TO FINISH ESCORTING HER TO THE FRONT OF THE PROPERTY, HE ALSO NOTICED WHAT HE BELIEVED THROUGH HIS TRAINING AND EXPERIENCE TO BE A STRONG ODOR OF A ALCOHOLIC BEVERAGE COMING FROM MCNEILS BREATH. OFFICER COOPER ADVISED MCNEIL TO TAKE A SEAT DUE TO HER HOSTILE NATURE. MCNEIL REFUSED TO SIT DOWN AND DEMANDED, "GET MY SHOES." I THEN ADVISED MCNEIL TO SIT DOWN, AND SHE STATED, "GO AHEAD AND ARREST ME, BUT I DON'T HAVE TO SIT." OFFICER COOPER AND I LOWERED MCNEIL TO THE GROUND IN A SITTING POSITION AGAINST HER WILL. MCNEIL REPEATEDLY YELLED THAT SHE WAS A CITY-COUNTY COUNCIL MEMBER AND THAT OFFICERS WERE NOT ALLOWED TO ARREST HER. SERGEANT HUBER, ID H4575, ALONG WITH SERGEANT MINCH, ID M7720, ARRIVED ON SCENE TO ASSIST WITH THE INVESTIGATION. OFFICER COOPER AND OFFICER HUXLEY WENT BACK UP TO THE HOUSE TO ENSURE THAT THE ORIGINAL INVESTIGATION WAS CONDUCTED. I ARRESTED MCNEIL FOR BATTERY WITH INJURY ON A LAW ENFORCEMENT OFFICER AND #D FELONY AND RESISTING LAW ENFORCEMENT. I WAS CHECKED OUT AT METHODIST OCCUPATIONAL HEALTH FOR INJURY TO MY LEFT HAND. IN THE ATTEMPT TO INVESTIGATE THE ORIGINAL REPORT, OFFICER COOPER WENT TO ██████ MEDFORD TO SPEAK TO THE JUVENILE IN QUESTION AND HER GRANDFATHER, IN QUESTION, AND HER GRANDFATHER, REFERENCE THE ALLEGED SEXUAL ABUSE THAT HAD TAKEN PLACE. DURING THE QUESTIONING, OFFICER COOPER WAS ABLE TO DETERMINE THAT IF ABUSE HAD OCCURRED, IT HAD OCCURRED SEVERAL YEARS AGO. OFFICER COOPER SPOKE TO THE JUVENILE, AND SHE STATED THAT, "THE EVENTS HAPPENED WHEN I WAS A BABY, ██████ TOUCHED ME AND MY COUSIN IN OUR PRIVATES." OFFICER COOPER THEN ASKED IF THAT HAD HAPPENED TODAY, AND SHE REPLIED, "NO. WHEN I WAS A BABY." OFFICER COOPER ASKED, "ARE YOU A BABY NOW?" AND SHE REPLIED, "NO." SHE THEN STARTED TO TELL OFFICER COOPER THAT ██████ TOOK KEYS THAT BELONGED TO HER GRANDFATHER AND WAS TRYING LEAVE WHEN HER MOM (MAKING REFERENCE TO MCNEIL) TRIED TO WRESTLE THE KEYS OUT OF HIS HANDS. OFFICER COOPER ASKED HER IF THAT HAD OCCURRED TODAY. SHE THEN SAID, "█████ PULLED UP MY SKIRT." OFFICER COOPER THEN ASKED IF THAT HAPPENED TODAY, AND SHE STATED, "NO, WHEN I WAS A BABY, I'M JUST SAYING WHAT MOM TOLD ME TO." OFFICER COOPER THEN BEGAN TO SPEAK TO THE GRANDFATHER, ██████ STATED THAT THE GRANDDAUGHTER HAS LIVED WITH HIM IN MUNCIE MOST OF HER LIFE AND IT WAS JUST RECENTLY THAT SHE MOVED TO INDIANAPOLIS. ██████ STATED THAT HE KNOWS ██████ BECAUSE HE DOES WORK FOR HIM PART TIME. ██████ ALSO LIVES SEVEN BLOCKS AWAY

FROM ██████████ IN MUNCIE, INDIANA. ██████████ AND THE JUVENILE HAVE INTERACTED IN THE PAST, BUT TO HIS KNOWLEDGE THEY HAVE NEVER BEEN ALONE TOGETHER. ██████████ DOES NOT BELIEVE THAT ██████████ WOULD DO ANY HARM TO HIS GRANDDAUGHTER. OFFICER COOPER CONTACTED CPS AND SPOKE TO DETECTIVE CASSIDY AND ADVISED HER OF THE POSSIBLE ASSAULT ON THE JUVENILE. BEFORE BEING LOADED INTO THE WAGON, I WAS SPEAKING TO MCNEIL AND ADVISED HER OF THE FACT THAT SHE HAD BEEN DRINKING WAS NOT HELPING THE SITUATION. MCNEIL STATED, "I HAVEN'T BEEN DRINKING, I'VE ONLY HAD TWO MARGUERITAS." MCNEIL THEN REQUESTED TO TAKE A PORTABLE BREATH TEST. WHEN OFFICER HUXLEY OFFERED HER THE TEST, SHE REFUSED TO TAKE IT STATING, "I CHANGED MY MIND, I AINT TAKING NO TEST CAUSE I AINT DRUNK. I WAS LATER ADVISED BY THE WAGON DRIVER THAT WHEN MCNEIL ARRIVED AT APC, SHE HAD URINATED IN HER PANTS AND IN THE WAGON. ALL EVENTS OCCURRED IN MARION COUNTY, INDIANAPOLIS, INDIANA.
